

BriFlex<sup>™</sup> is a flexible lighting system using LED technology. The flexible LED system is consisted of a series of SMD LEDs (Light Emitting Diodes) mounted on an elongated flexible PCB strip. The LED strip comes in standard 5 meter length. Each piece can be cut or interconnected at each end to form a chain of light modules.

**BriFlex™** can be used to back lid a signage letter, retrofit light fixture and exit sign or mounted inside architecture ceiling as indirect lighting. This system actually consumes 80-90% less power compare to similar neon system.

There is many color choices for the LED: red, amber, yellow, green, blue and white. Installation is easy, each strip is equipped with double sided tape and installation can be done by untrained installer.

**BriFlex™** is very flexible and can be cut (at 3 LEDs interval) or connected end to end to form different length as desired. Therefore, it is very suitable for any applications and locations.



# Product Circuit Diagram (one unit length)




Fig 2. LED Strip Circuit Diagram
