






Fig.1. Maximum on-state dissipation, P_{tot} , versus average on-state current, $I_{T(AV)}$, where $a = form \ factor = I_{T(RMS)} / I_{T(AV)}$.




Fig.4. Maximum permissible non-repetitive peak on-state current I_{TSM} , versus number of cycles, for sinusoidal currents, f = 50 Hz.




Fig.2. Maximum permissible non-repetitive peak on-state current I_{TSM} , versus pulse width t_p , for sinusoidal currents, $t_n \le 10$ ms.




Fig.5. Maximum permissible repetitive rms on-state current $I_{T(RMS)}$, versus surge duration, for sinusoidal currents, f = 50~Hz; $T_{sp} \le 112 \,^{\circ}C$.







Fig.3. Maximum permissible rms current $I_{\text{T(RMS)}}$, versus solder point temperature T_{sp} .









PRINTED CIRCUIT BOARD
